 - There have been five (5) calls since the last board meeting. Two have involved motor vehicles, one wildland (smoke report), and one medical; all but one were mutual aid responses.
 - o The Chief is attending the Wildfire Academy in Colorado Springs.
 - An SFPD Wildland Fire Dispatch Program document was created; the policies and procedures were designed to address some of the issues discussed since the Fourmile Canyon Fire in September.
 - o A Member Information Handbook was created.
 - The Company Meeting was attended by all but two Fire Department Members. A new departmental structure based on Teams was introduced. The Members signed a Code of Conduct Statement of the Member Information Handbook.
