- SFPD will be participating in a six-district collaboration to try and obtain grant money for private homeowner mitigation.
- BMFA will not be able to perform the mitigation along CR83. This is due to the mitigation needs in their own district as well as the delay in community buy-in. BMFA's grant money will not be available for SFPD. CWPP will look into alternative resources to perform this mitigation and if any grant money is available.
- The County Commissioners approved improvements to the connecting road from the end of CR 83 (SFPD) to Mine Lane (BMFPD). Each district will be asked to contribute and maintain the road. This will be an emergency access road only.
 - Motion: To appoint the Chief to negotiate an agreement with Boulder County regarding the connection from County Rd 83 to Mine Lane with an initial cost of up to \$6,000 and a maintenance cost of up to \$1,000 per year, subject to final approval by the board. Motion was seconded and carried unanimously.
- SFPD Award banquet was held at the Lazy Dog and was well received.
