- for exclusion to the FMFPD for 5405 SCD. Fourmile is expected to act on that this month. A. Kirton will ask Jeff Richey to submit a petition for inclusion to SFPD.
- There were five candidates for the three open board positions in the upcoming election.
 Two of the candidates decided to withdraw their self-nomination forms rather than go through the election process. The three remaining candidates are Cathy Shoenfeld, Dan Fischer, and Dick Smith. We can therefore cancel the election that was scheduled for May 5, 2020. A. Kirton submitted the required publication.

EMS COVID-19 RESPONSE GUIDELINES

March 10, 2020

This document is designed to provide Emergency Medical Services (EMS) practitioners with guidance regarding the outbreak of 2019 Novel Coronavirus (COVID-19) that began in Wuhan City, Hubei Province, China in December 2019. This guidance serves as a reference to SFPD responders for general considerations and the protection of responders and has been written in unison with the Four Mile Fire Protection District. Note that this information is changing rapidly and you should go back to recheck these resources regularly.

Pre-Hospital Response for EMS / Fire:

- Full universal precautions should be adhered to when treating individuals that are complaining of Cold / Flu
 like symptoms including coughing, sneezing, difficulty breathing, chest pain or discomfort, aches and pains,
 nausea, fever or any other symptoms that can be attributed to a respiratory illness. This includes any
 medical call where the patient may not have any complaints but other parties nearby or in the residence
 appear to be unwell.
- These precautions should include gloves, gown, face mask (N-95 recommended), and goggles (not just eyeglasses) that provide a seal around the skin.
- These measures should be donned before entering any structure that is suspected of housing an infected patient. In addition to precautions worn by responders, a face mask should be provided to the patient in order to limit contaminates from spreading. Both 4532 and 4501 are equipped with face masks.
- EMS providers should not be in the same structure as a patient without donning the required PPE first. Being in a hallway adjacent to the patients location is insufficient. Don your PPE outside before you enter the structure.
- If the Patient can follow commands, the face mask may be thrown to the patient to don themselves and a liquid disinfectant may be handed to the patient to clean hands.
- It is also recommended that a minimum number of responders make patient contact, if at all. If AMR is on scene or arrival is imminent, incident command can evaluate and determine whether entry is necessary (based on patient urgency, other responders, AMR, scene, etc.). Even if AMR is on scene evaluate the necessity of each responder entering the structure or approaching the patient.

- If SFPD is first on scene PPE needs to be worn and one responder enters the home at a time, unless otherwise required.
- Resources should stage before entering a structure that houses a possibly infected individual until a treatment plan is defined unless an immediate life threat is suspected.
- Boulder County Dispatch will immediately begin screening all 911 calls for possible COVID-19 exposure.
 Dispatch will then air any positive screening results over County Dispatch channel so that responders may be prepared for patients that may have been exposed.

We will continue monitoring the outbreak and its severity. Should the situation worsen, we will update these guidelines and include responding to any medical call with protective gear even when patients or victims are asymptomatic, also due to the long incubation time of COVID-19, in addition to setting up a decontamination station. Keep in mind that effective disinfectants have been added to 4532 and 4501 as well.
