• There have been complaints regarding cars blocking access/egress gates at the Sunshine Saddle. Signage is needed in 'no parking' areas. Chief will follow up with the county about signage.

- Covid-19/Coronavirus. Awaiting Colorado surge as more retail stores are opening up again. A surge

- 2. Most responders have done their wildland refresher and pack test.
- 3. New Truck RFP. Will be receiving an updated proposal from Rosenbauer so far. KME and BME are still expected to provide one as well before June 12.
- 4. We are still at Level 1 Fire Restrictions.
- 5. There have been complaints that the Sunshine saddle has an excessive amount of traffic and parked cars (hikers avoiding public trails), blocking the emergency access/egress. We are trying to keep getting information from residents whenever it happens and will try to get some "no parking" signs installed by the County. However, it is more likely that they will tell us that it is our responsibility.
