Minutes of the Regular Meeting of the Board of Directors of the Sunshine Fire Protection District December 8, 2020

Call to Order

The meeting was held virtually by Zoom.

The meeting was called to order at 7:31 PM and quorum was established. See Agenda below.

Approval of Minutes

Minutes from the November Board meeting were reviewed.

MOTION: To approve November Board Meeting Minutes was seconded and carried unanimously.

Treasurer's Report

Treasurer's report was reviewed.

MOTION: To approve November Treasurers Report was seconded and carried unanimously

<u>Fire Chief's Report – Review of report</u>

- There are currently three engines out of service, 4502, 4532, and 4541. 4541 is currently being serviced by the state to fix multiple issues. 4532 is being serviced to replace the power steering pump and foam controller.
- The new brush truck, 4535, has been put into service by borrowing equipment from some of the other vehicles.
- We are continuing to purchase new supplies and equipment for new firefighters and the new brush truck. Procurement will take well into the next year.

Other Business

- The 2021 budget was reviewed in detail
 - Expense item 6650 Training and Education had been set at \$5000, which was a reduction from the 2020 budgeted amount because of the anticipated effect of COVID on in person training. Chief Schmitt felt that in person training would be available and pointed out that we have a number of new firefighters who will be taking classes. The budgeted amount was increased to \$7500.
- 2021 Budget was approved as amended. The Board unanimously passed two Resolutions related to the budget. Both Resolutions will be included in the budget package that is sent to the state.

RESOLUTION: To adopt 2021 Budget for the Sunshine Fire Protection District for the calendar year beginning on the first day of January 2021 and ending on the last day of December 2021.

RESOLUTION: Levying General Property Taxes for the Year 2020 to help defray the costs of government for the Sunshine Fire Protection District for the 2021 budget year.

- Proposed QuickBooks and accounting changes were discussed as a means to make the
 separation between the Fire Department, CWPP and the Cistern Fund clearer in terms of
 accounting. The decision was made to adopt the majority of the changes in the new fiscal
 year. One of the suggestions was to fully document what each of the accounts are used for
 within QuickBooks and also fully document all of the changes and the reasons for making
 the change.
- SFPD has received approval for the Limited Impact Special Use Review for the Community Fire Cistern at 1462 CR 83. The Letter of Determination specifies that a Building Permit and Grading Permit be obtained before construction can begin. The plan is to start that work in January with the plan being a June installation of the cistern.
- Update on Rosenbauer Timberwolf Purchase was discussed
 - Pre-Construction Notes (PCN) have been approved by SFPD. This is the step that starts the build process, including the chassis order.
 - There were a number of changes that were requested which will result in a cost increase of \$5,558 (~1%). Total cost is now \$492,786 after chassis pre-payment discount.
