Minutes of the Regular Meeting of the Board of Directors of the Sunshine Fire Protection District March 14, 2023

Call to Order

The meeting was held at Station 1.

The meeting was called to order at 7:32 PM and a quorum was established.

Attendance

Approval of Minutes

Minutes from the February Board meeting were reviewed.

Dan noted a change: Keep the items purchased in separate spreadsheet. Will add that to the Feb minutes.

MOTION: To approve Board Minutes as amended. Motion was seconded and carried unanimously.

Review/Approve Treasurer's Report

- Checking: Starting to get property tax income. Global med charge was for training class. legal expense was for how to handle the payroll. Wildlife mitigation was for hazardous tree removal. Annual membership dues were paid to SDA. \$1.3K for grant preparation for regional radio application that was approved in Dec.
- Credit Card: Doors and locks for Station 2 were purchased. Annual license for QuickBooks software.
- P&L: Capital Equipment budget is good. Lots of expense for non-capital equipment. The Board needs to keep an eye on that. Need to create a grant writing services line item in the budget and will need to budget for that in the future.
- Update on fraud incident. Fraudulent attempts were made to access Wells Fargo and
 First Internet accounts. Dan was able to resolve this and make appropriate changes to
 account securities in terms of changing passwords, authorization, and to conduct
 continuous monitoring. The Board thanks Josh King for his help in resolving the fraud.

MOTION: To approve Treasure's report. Motion was seconded and carried unanimously.

Chief's Report

- 4505 is going into the shop next week. All items on the punch list are under warranty. Expected down time is 1 week.
- Board member Special District training. The Chief recommend that a member of the board take that training. The training is in regard to board member personal responsibility and liability. There also may be a handbook that we can download and distribute.
- The SFPD logo should be trademarked. Michael Johnson has volunteered to trademark our logo pro bono. Someone is making SFPD patches and selling them on line. There will be a fee to do the trademark and it will take 1-2 years to go through the process.

- The doors and locks for Station 2 have arrived. The contractor has been scheduled to install them.
- Don Dick left 15 % of his trust to the district. The Chief wants to make a commemorative plaque for Don and is looking for suggestions on what to put on plaque. Maybe gratitude from SFPD and the community.
- The Chief wants to train all firefighters on using Polygons. So that whoever shows up for a call can call it in to the County. These are predetermined area perimeters. They are aligned with the predicted water & fire flow directions. Every district has 1 or more of them. They are used for evacuation warnings so don't have to give street names. SFPD is in polygon 45A. They use the tablets in the trucks to determine where they are and in what polygon.
- The Chief asked about the status of setting up a 501c3. It has yet to be followed up. Jean and Kathy will check with Allison Shetter to see if she is willing to set that up. It would be used for organizations who want to make donations but need a 501c3 to be able to do that. Boulder Mountain has one setup. We can use them for guidance.
- Wish list confusion. Need to have it as a stand-alone list to let community members know what is needed and then what was purchased.

Other Business

Election cancellation

We need to pass a resolution cancelling the election and to publish and file the results to the appropriate venues.

MOTION: A motion was made to pass resolution 2023-01 to cancel the 2023 election and declare the 3 self-nominated candidates (Richard Smith, Daniel Fischer, and Pat Noyes) as elected members to the SFPD Board. The motion was unanimously approved.

- <u>Firefighter Appreciation Dinner</u> Starts at 5:30 Wednesday March 15. All board members are welcome and encouraged to attend. Emily Gebhart has done a great job organizing that.
- Contract Firefighter Program, changes to procedures, status Thanks to everyone for quick response after e-mail information Jean sent on Feb. 26 about changes to the program (i.e. contracting for invoicing, monthly payroll). In the meantime, Chief, Dan and Jean met with PJ Tillman who we have contracted with to do the billing. She helped answer many questions and gave us advice on setting up our system. She suggested a new look at our rates and what we need to submit for Cost-of-Living adjustments. Jean suggested that we consider a motion about the change from paying when we receive funds to a monthly payroll, as advised by our attorney. It was also recommended that we don't wait to do the payments. PJ Tillman will be handling the payroll for any of the contractor Firefighters that want to be paid that way. MOTION: A motion was made to change from paying the contract Firefighters when we receive funds to a monthly payroll. The motion was seconded and passed unanimously. Dan found information regarding what a Cost-of-Living adjustment should be for our locality. This is needed to finalize the pay rates for the contract Firefighters. The amount will be 28.9% above the national average. That number is for the City of Boulder. We had been using a factor of 1.4. A question was raised whether we need to add the Federal unemployment tax at well.

- Boulder County Commissioners Town Hall Thursday, March 16 at 5:30. everyone is encouraged to attend. They will be coming with a presentation and then will take questions.
- CWPP update, Meeting March 21 via Zoom all are encouraged to attend
- Exploration of Long-Range Options
 Jean indicated that she would like to have a 10-yr strategic plan. There are a lot of questions about what we could do. Alan has a capital plan and an analysis had been done on purchasing 4505. Chief mentioned Boulder County requirement for dual band radios by certain date. Bunker gear needs to be replaced from time to time. The gear expires after 10 yrs. These are on-going expenses. 4501 is 20 yrs old this year. We need to consider replacing it and to research what other issues that need to be addressed. What are the options, the priorities, and then need to decide how to proceed. Should define the limits of a plan and include thoughts on where the District community will be in the foreseeable future. Perhaps we could invite Alan Kirton to give

a presentation on past strategic plans. Pat Noves has volunteered to lead the

MOTION: A motion was made to move the SFPD Board Meeting permanently to 6:30 pm. The motion was seconded and approved.

- Website update: Eric Bader designed and hosts the web site. There is no cost to the district. There is a need for the web site to be more dynamic. There is a company (StreamLine) whose business is to setup web sites for Special Districts. They make sure the sites are compliant with rules and accessibility. It would be a better way to keep the community informed. However, there is a monthly fee of about \$100. Comments from Board members questioned whether the return would be worth that level of expenditure. The Chief mentioned that Michael AbiEzzi has experience in that area and might be interested in helping update and hosting the website.
- John proposed that we establish 2 committee chairs, one for fundraising and a second for community events. He proposed that these chairs would report to the Board and that the process be formalized by the Board. This would require defining what the roles would be for those Chairs. Each chair would then setup their own committee. Board members will consider how to define the roles of these positions and discuss the topic further at the next Board meeting.

Chief Report - Board Meeting 03/14/2023

- 1. **4505:** Will go back to shop next week to get a punch list taken care of. Expected time is 1 week.
- 2. **Board Member Special District Training:** Recommend a member of the board to take a look at what training may be required for board members. A number of districts have started making some a requirement.
- 3. **SFPD Logo Trademark:** Our logo occasionally gets found at different places online. I have asked Michael Johnson to take steps to trademark our logo. There will be a fee associated with it and the process will take 1-2 years. He will do the work pro bono.
- 4. **Station 2 Doors:** Doors and locks have arrived. The contractor is 3 weeks out to do the work.
- 5. **Don Dick:** Paperwork from his trust has been received, and both Dan and I have requested a report.
- 6. **Don Dick:** We had previously talked about a commeorative plaque with Don's name for his time as a firefighter and board member of the department. I need suggestions of what to have written on it, and its size.
- 7. **Polygons:** We are going to train all firefighters on the use of Polygons in Boulder County. We are changing the structure where we used to just have Officer level members call in for an evacutation. This was the standard across the County, and some are still using that. We find that with the likelyhood of non-Officer members showing up that it warrants and update of the procedure. We will have 2 firefighters confirm a polygon with each other before calling dispatch to evacuate an area or region, and we will still have a single officer being able to call it in. This is one reasy why we needed tablets in our engines and already have two, in 4532 and 4505.
- 8. **501c3:** Do we have a plan to continue the progress on this? Any help I can find for us? We keep missing opportunities and this should be a priority.
- 9. **Wishlist:** Some of the items from the wishlist have been purchased. Would like clarification as I received confusing messaging.
